



The authors explain the examination process for latent prints and how they are identified with these systems. While the primary focus is automated fingerprint identifications, the book also explores the emergence and use of fingerprints in other biometric systems as well as the known limitations and advantages of these systems.

Automated Fingerprint Identification Systems (AFIS) covers the whole range of topics concerning AFIS systems including hotly debated issues like why identifications are made on one database that are not made on another database, and why there are missed identifications. In order to answer these questions and others like them, the author employs a SWOT analysis, which examines the Strengths, Weaknesses, Opportunities, and Threats of AFIS in addition to suggesting improvements to the overall number of positive identifications. The book goes beyond process to discuss interoperability, management strategies for large databases, contract development, lights-out verification, and other issues which impact automated identifications. The book will appeal to criminal justice policy makers, managers, administrators and students. There are also two case studies included that address the Identification Rate for latent print identifications as well as the improved uses of the Unsolved Latent Print file.
